Terms and Conditions for Participation on a RapidShot Shooting Lane

1. The Guest/Member/Applicant enrolled in hockey training and/or competition is subject to the rules and regulations of RapidShot North America Inc., (herein called RapidShot) which term includes its officers, directors employees, agents and affiliates, in effect from time to time and agrees to accept such rules and regulations
2. The Guest/Member/Applicant acknowledges that hockey activities, training and competitions are inherently dangerous activities. The Guest/Member/Applicant has made a voluntary choice to participate in these activities despite the risk that they present. In consideration of the Guest/Member fee being permitted to participate in the use of RapidShot and the facilities where it is located, the Guest/Member/Applicant agrees to assume any and all risks of injury or death which might be associated with or result from the Guest/Member/Applicants participation or interaction with the equipment, whether such risks are reasonably foreseeable or due to unforeseen circumstances.
3. The Guest/Member/Applicant understands that RapidShot assumes no responsibility for any risk of harm or injury to the Guest/Member/Applicant or for any loss or damage to the Guest/Member/Applicants equipment or personal items, howsoever caused.
4. The Guest/Member/Applicant acknowledges that RapidShot will record information and data relating to the Guest/Member/Applicants use of RapidShot equipment including without limitation the Guest/Member/Applicant's name, personal information performance in the use of RapidShot's equipment and ranking relative to other Guest/Member/Applicants (collectively referred to as the "Data"). The Guest/Member/Applicant acknowledges that this consent is given in consideration of a grant of a license to use RapidShot's facilities or related facilities where RapidShot equipment might be located, without any expectation or entitlement to compensation of any kind from RapidShot save and except for any prizes which may be due as a result of placing in any Contests. Breach of any term of this Acknowledgement will entitle RapidShot to immediately forfeit the Guest/Member/Applicant's fees paid without refund.
